Terms and conditions

1. Information on how to enter and prizes form part of these Conditions of Entry. Entry into this promotion is deemed acceptance of these Conditions of Entry. Entry is via www.facebook.com/studyadelaide
2. Entry is free and open to people aged 18 years or older who complete, in full, the entry form available www.facebook.com/studyadelaide during the promotional period and are international students enrolled at a South Australian learning institution for semester 1, 2012. Employees and immediate families of the Promoter and suppliers, providers and agencies associated with this promotion are ineligible to enter.
3. The promotion commences 1 October-2011 at 12am (Australian Central Standard Time) and closes 1 December 2011 at 12pm (Australian Central Standard Time). To enter the promotion, eligible entrants must complete the entry form available at www.facebook.com/studyadelaide during the promotional period.
